#### **Notice of Data Breach**

#### Dear <<Full Name>>:

Because iHeartMedia + Entertainment, Inc. recognizes the importance of protecting information, we are writing to let you know that we have identified and addressed a security incident involving some of your information. This notice explains the incident, the measures we have taken in response, and some additional steps you may consider taking.

What Happened? Between December 24, 2024, and December 27, 2024, an unauthorized actor viewed and obtained files stored on systems at a small number of our local stations. As soon as we became aware, we immediately implemented our response protocols, took measures to contain the activity, and launched an investigation. Additionally, a cybersecurity firm that has assisted other companies in similar situations was engaged, and we notified law enforcement.

We conducted a careful review of the files and, on April 11, 2025, determined that one or more of the files contained your information.

What Information Was Involved? The information included your name, Social Security number, tax identification number, driver's license number, and/or state identification card number. The information also may have included your passport number or other governmental identification number, date of birth, financial account information, payment card information, health information and/or health insurance information.

What We Are Doing. We wanted to make you aware of this incident and to assure you that we take it seriously. We have arranged for you to receive one year of complimentary access to Equifax credit and identity monitoring, as discussed below. We regret that this incident occurred and apologize for any inconvenience it may cause, and to prevent similar occurrences in the future we have strengthened our existing security measures.

What You Can Do. You can enroll in the complimentary credit and identity monitoring product we have arranged for you, which is designed to detect potential misuse of your information and offers identity protection solutions aimed at promptly identifying and resolving instances of identity theft.

NOTE: Activating this product will not hurt your credit score. For further guidance on identity theft prevention and details regarding your Equifax credit and identity monitoring, including instructions on how to activate your access, along with additional measures you can take, please refer to the accompanying pages following this communication.

Locking your Equifax credit report will prevent access to it by certain third parties. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your state. You can obtain information from these sources about steps an individual can take to avoid identity theft as well as information about fraud alerts and security freezes. You should also contact your local law enforcement authorities and file a police report. ### **Fraud Alerts and Security Freezes**

**Fraud Alerts:** There are two types of general fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years.

To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert on their versions of your report.

For those in the military who want to protect their credit while deployed, an Active-Duty Military Fraud Alert lasts for one year and can be renewed for the length of your deployment. The credit bureaus will also take you off their marketing lists for pre-screened credit card offers for two years, unless you ask them not to.

*Credit or Security Freezes:* You have the right to put a credit freeze, also known as a security freeze, on your credit file, free of charge, which makes it more difficult for identity thieves to open new accounts in your name. That's because most creditors need to see your credit report before they approve a new account. If they can't see your report, they may not extend the credit.

How do I place a freeze on my credit reports? There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. You'll need to supply your name, address, date of birth, Social Security number and other personal information.

After receiving your freeze request, each credit bureau will provide you with a unique PIN (personal identification number) or password. Keep the PIN or password in a safe place. You will need it if you choose to lift the freeze.

How do I lift a freeze? A freeze remains in place until you ask the credit bureau to temporarily lift it or remove it altogether. If the request is made online or by phone, a credit bureau must lift a freeze within one hour. If the request is made by mail, then the bureau must lift the freeze no later than three business days after getting your request.

If you opt for a temporary lift because you are applying for credit or a job, and you can find out which credit bureau the business will contact for your file, you can save some time by lifting the freeze only at that particular credit bureau. Otherwise, you need to make the request with all three credit bureaus.

**Protecting Health Insurance or Medical Information:** It is always advisable to review any statements you may receive from your health insurer or healthcare providers. If you see charges for services that you did not receive, contact your insurer or provider immediately.

**New Mexico:** A Summary of Your Rights Under the Fair Credit Reporting Act: The federal Fair Credit Reporting Act (FCRA) promotes the accuracy, fairness, and privacy of information in the files of consumer reporting agencies. There are many types of consumer reporting agencies, including credit bureaus and specialty agencies (such as agencies that sell information about check writing histories, medical records, and rental history records). Your major rights under the FCRA are summarized below. - You must be told if information in your file has been used against you.
- You have the right to know what is in your file.
- You have the right to ask for a credit score.
- You have the right to dispute incomplete or inaccurate information.
- Consumer reporting agencies must correct or delete inaccurate, incomplete, or unverifiable information.
- Consumer reporting agencies may not report outdated negative information.
- Access to your file is limited.
- You must give your consent for reports to be provided to employers.
- You may limit "prescreened" offers of credit and insurance you get based on information in your credit report.
- You have a right to place a "security freeze" on your credit report, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization.
- You may seek damages from violators.
- Identity theft victims and active duty military personnel have additional rights.
