The purpose of this notice is to inform you of a recent incident that may affect the security of some of your personal information. While we currently have no evidence of actual misuse of your information, we are providing you with information about the incident, our response to it, and information related to how you may better protect your personal information.

What Happened? We became aware of unauthorized access to our system and a ransom demand, which we promptly investigated. Although it was not confirmed that your personal information was misused by an unauthorized actor, we could not rule out that possibility.

What Information was Involved? A thorough review of the system contents determined that, at the time of the incident, the affected systems contained personal information, such as your name, contact information, driver's license and social security number.

What Are We Doing? Information, privacy, and security are among our highest priorities. As such, upon learning of this incident we quickly investigated, promptly disabled access to the affected systems, implemented increased security measures, reported the incident to law enforcement, and are regularly reviewing our policies and procedures relating to data security.

We have also secured the services of NortonLifeLock Inc. to provide identity and credit monitoring services, at no cost to you, for two years. Please review the enclosed NortonLifeLock Enrollment Information for additional details, including enrollment instructions.

What Can You Do? We encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious activity for the next twenty-four (24) months. We also encourage you to enroll with NortonLifeLock to receive the identity and credit monitoring services. Please note that you must enroll directly. We are unable to enroll in these services for you.

Fraud Alert Information

Whether or not you enroll in the credit monitoring product offered, you also have the right to place an initial fraud alert on your file at no cost. An initial fraud alert lasts one (1) year and is placed on a consumer's credit file. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven (7) years. Fraud alert messages notify potential credit grantors to verify your identification before extending credit in your name in case someone is using your information without your consent. A fraud alert can make it more difficult for someone to get credit in your name; however, please be aware that it also may delay your ability to obtain credit.

Free Credit Report Information

You have rights under the federal Fair Credit Reporting Act. These include, among others, the right to know what is in your credit file; the right to dispute incomplete or inaccurate information; and the right to ask for a credit score. Under federal law, you are also entitled to one free credit report once every 12 months from each of the above three major nationwide credit reporting companies. Your complaint will be added to the FTC's Consumer Sentinel database, where it will be accessible to law enforcement for their investigations.

You have the right to request a free security freeze (aka "credit freeze") on your credit file by contacting each of the three nationwide credit reporting companies via the channels outlined below. When a credit freeze is added to your credit report, third parties, such as credit lenders or other companies, whose use is not exempt under law will not be able to access your credit report without your consent. A credit freeze can make it more difficult for someone to get credit in your name; however, please be aware that it also may delay your ability to obtain credit. You may also contact any of the consumer reporting agencies or the FTC for more information regarding security freezes.

You must separately place a credit freeze on your credit file at each credit reporting agency. The following information should be included when requesting a credit freeze:

- 1) Full name, with middle initial and any suffixes;
- 2) Social Security number;
- Date of birth (month, day, and year);
- 4) Current address and previous addresses for the past five (5) years;
- 5) Proof of current address, such as a current utility bill or telephone bill;
- 6) Other personal information as required by the applicable credit reporting agency;

If you request a credit freeze online or by phone, then the credit reporting agencies have one (1) business day after receiving your request to place a credit freeze on your credit file report. If you request a lift of the credit freeze online or by phone, then the credit reporting agency must lift the freeze within one (1) hour. If you request a credit freeze or lift of a credit freeze by mail, then the credit agency must place or lift the credit freeze no later than three (3) business days after getting your request.

Additional Information

You can further educate yourself regarding identity theft, fraud alerts, security freezes, and the steps you can take to protect yourself by contacting the consumer reporting agencies, the Federal Trade Commission, or your state Attorney General.
