

# **EXHIBIT 1**

By providing this notice, WIRX Pharmacy (“WIRX”) does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

### **Nature of the Data Event**

On or about December 7, 2025, WIRX became aware of suspicious activity in its computer environment. WIRX promptly began an investigation to determine the nature and scope of the event. The investigation determined that between December 6, 2025, and December 7, 2025, data from certain systems was accessed or acquired without authorization. WIRX then reviewed the data involved to determine what information was present and to whom such information relates. On January 23, 2026, WIRX review determined that the files involved contain personal information.

The personal information that could have been subject to unauthorized access includes name and Social Security number.

### **Notice to Maine Residents**

On February 5, 2026, WIRX began notifying individuals by posting notice to its website. On this date, it also submitted notice to the U.S. Department of Health and Human Services (“HHS”) and relevant prominent media pursuant to the Health Insurance Portability and Accountability Act (HIPAA). On or about February 12, 2026, WIRX continued to provide written notice of this event to approximately four (4) Maine residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

### **Other Steps Taken and To Be Taken**

Upon discovering the event, WIRX moved quickly to investigate and respond to the event, assess the security of WIRX systems, and identify potentially affected individuals. Further, WIRX notified federal law enforcement regarding the event. As part of WIRX’s ongoing commitment to information security, it is reviewing its existing policies and procedures to reduce the likelihood of similar future events. As an added precaution, WIRX is offering credit monitoring and identity restoration services for twelve (12) months at no cost to these affected individuals.

Additionally, WIRX is providing affected individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to relevant institutions. WIRX is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

WIRX is providing written notice of this event to relevant state and federal regulators, as necessary. As noted above, WIRX is also notified the U.S. Department of Health and Human Services and prominent media pursuant to the Health Insurance Portability and Accountability Act (HIPAA).

WIRX Pharmacy (“WIRX”) writes to inform you of a recent event that involves some of your personal or protected health information. We are providing you with information about the event, our response, and resources available to help you protect your information, should you feel it appropriate to do so.

**What Happened?** On or around December 7, 2025, WIRX became aware of suspicious activity in our network environment. We secured our systems and launched an investigation into the nature and scope of the activity. The investigation determined that certain data on WIRX systems was accessed or acquired without authorization from December 6, 2025 to December 7, 2025. We undertook a comprehensive review of the files involved to identify what information was contained within them and to whom the information relates. Through this effort, WIRX determined on January 23, 2026 that personal or protected health information related to certain individuals was present in the affected files.

**What Information Was Involved?** The types of personal or protected health information present in the files involved may include your name and the following: <<*data elements*>>.

**What We Are Doing.** We take this event seriously, and the confidentiality, privacy, and security of information in our care are among our highest priorities. Upon learning of this event, we moved quickly to investigate and respond, assess the security of our network, and notify affected individuals. We also reported this event to federal law enforcement. As part of our ongoing commitment to information security, we are reviewing our existing policies and procedures to reduce the likelihood of similar future events.

Additionally, we are offering you complimentary credit monitoring services for [Extra2] months through Experian. You can enroll in these services by following the instructions contained in the *Steps You Can Take to Help Protect Personal Information*. We are unable to enroll you on your behalf.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account and explanation of benefits statements and monitoring your free credit reports for suspicious activity and to detect errors. Suspicious activity should be promptly reported to relevant parties such as an insurance company, healthcare provider, and/or financial institution. You may also enroll in the complimentary credit monitoring services we are offering through Experian. Additional information can be found in the enclosed *Steps You Can Take to Help Protect Personal Information*.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
