We are writing to inform you of a recent incident involving your personal information. While we are not permitted to share specific details of how the exposure occurred, we want to assure you that we are taking this matter seriously. It is important to us that you are fully informed of any situation that may affect your privacy.

What Happened?

We recently discovered that certain elements of your protected information were potentially exposed to another individual. This error was immediately reported to the MA PDP program.

What Information Was Involved?

The information involved in this incident includes your name, Provider ID, Provider Username, Password and Pin.

What We Are Doing

We immediately took steps to contain the incident and conducted a thorough investigation to understand what happened. Our team has reviewed our processes to ensure that this type of error does not happen again. We are also reinforcing staff training on our privacy practices to help prevent future incidents.

What You Can Do

At this time, there is no evidence that your information has been misused. However, as a precaution, you may place a freeze on your credit report for free by contacting each of the three major credit reporting agencies. You can submit your request online, by phone, or by mail.
