## NOTICE OF [Extra5]

Dear Sample A. Sample:

Ailco Equipment Finance Group, Inc. (“Ailco”) was recently informed that one of its service providers, Kaaj Technologies Inc. (“Kaaj”), experienced a data privacy incident. Kaaj provides a credit analysis platform to assist Ailco in processing its small business loan applications. We are providing you with an overview of the incident, our response, and resources to help further protect your information, should you feel it necessary to do so.

**What Happened?** Kaaj recently learned of anomalous activity within its environment. Kaaj indicated that it launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. Its investigation determined that its environment was subject to unauthorized access on January 13, 2026 and some data was copied. Ailco learned of the incident on February 11, 2026.

As part of the services provided by Kaaj, it maintained a database that may include certain loan application information provided by or on behalf of Ailco. The information in the database varies by individual, but generally includes an applicant’s name, address, and Social Security number. The raw loan package files provided by Ailco are not maintained in our database and as such, were not impacted by this incident.

**What Information Was Involved?** Kaaj determined that the following information related to you was located in the database: your full name, [Extra1]. Kaaj nor Ailco knows with certainty whether your information was copied by the unauthorized actor.

**What We Are Doing.** Ailco takes the security of information in our care and our systems very seriously. As soon as we were informed of the activity, we launched an investigation to confirm the security of our network. In addition to its ongoing compliance and security program, Kaaj has indicated it took further steps to strengthen its environment, including implementing additional safeguards and enhanced monitoring.

## ADDITIONAL DETAILS REGARDING YOUR [Extra4]-MONTH EXPERIAN IDENTITYWORKS MEMBERSHIP

A credit card is not required for enrollment in Experian IdentityWorks. You can contact Experian immediately regarding any fraud issues, and have access to the following features once you enroll in Experian IdentityWorks:

- **Experian credit report at signup:** See what information is associated with your credit file. Daily credit reports are available for online members only.\*
- **Credit Monitoring:** Actively monitors Experian file for indicators of fraud.
- **Identity Restoration:** Identity Restoration specialists are immediately available to help you address credit and non-credit related fraud.
- **Experian IdentityWorks ExtendCARE™:** You receive the same high-level of Identity Restoration support even after your Experian IdentityWorks membership has expired.
- **\$1 Million Identity Theft Insurance\*\*:** Provides coverage for certain costs and unauthorized electronic fund transfers.

### Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

**Additional Information**

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
