Williams Accountancy Corporation (“Williams Accountancy” or “we”) values and respects the privacy of your information, which is why we are writing to advise you of an incident that may have involved some of your personal information. While we have no evidence that the information involved in this incident has been misused for the purpose of committing fraud or identity theft, we want to make you aware of the incident and the steps we have taken to address it.

**What Happened?** On December 30, 2025, we discovered that an unauthorized third party had gained access to our network. Upon identifying the incident, we promptly took steps to contain and remediate the incident and began an internal investigation. We also engaged a forensic security firm to assist with our investigation and ensure the security of our computer network. The forensic investigation determined that an unauthorized third party accessed certain systems on our network, and acquired files from those systems on December 25, 2025 and December 26, 2025.

**What Information Was Involved?** After identifying the list of the potentially acquired files, we reviewed them to see what, if any, personal information they contained. Based on the results of our investigation, on February 5, 2026, we determined that the files could have contained information provided to Williams Accountancy which could include your name, date of birth, Social Security number, and bank account number.

**What We Are Doing.** In addition to the actions described above, we are taking further steps to reduce the risk of this type of incident occurring in the future, including reviewing our technical security measures. Also, although we have no evidence that information potentially involved in this incident has been used for identity theft or fraud, we have arranged for you to enroll in a complimentary membership of Experian IdentityWorks Credit 3B, if you would like to do so. This product helps enrollees detect possible misuse of their personal information and provides identity protection services focused on prompt identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you. **For more information, including instructions on how to activate your complimentary membership, please refer to the additional information enclosed.**

**Fraud Alerts:** By law, you have the right to place a fraud alert on your credit report if you believe you have been, or are about to become, a victim of fraud or related crime. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. **Credit and Security Freezes:** By law, you have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company. Since the instructions for how to establish a credit freeze differ from state to state, please contact the three major credit reporting companies as specified below to find out more information:
