Notice of Data Breach

March 16, 2026 – Wound Technology Network, Inc. (“Woundtech” or “we”) is providing notice that it has experienced a cyber incident. Woundtech takes this incident very seriously and is providing information about the incident, our response to it, and resources available to individuals to help protect their information, should they feel it appropriate to do so.

What Happened? On or about December 6, 2025, Woundtech became aware of unusual activity in its network environment. Woundtech promptly began an investigation into the scope and nature of the incident. Woundtech retained a third-party cybersecurity firm to conduct a forensics investigation. On December 31, 2025, that investigation revealed that certain information may have been copied by an unauthorized individual as part of the incident. This activity occurred between December 6, 2025, and December 9, 2025. Woundtech then began a comprehensive review of the data set to determine whose information was impacted and the type of information. On March 2, 2026, Woundtech completed its review for purposes of identifying the potential notice population.

What Information Was Involved? The personal information involved varies by individual. For the information involved as to you, we would ask that you refer to your notice letter. Information potentially impacted may be: first name, last name, date of birth, telephone number, gender, clinical notes, medical health information, medical treatment information, medical diagnosis information, health insurance information, medical treatment images, and a very limited amount of Social Security numbers.

What We Are Doing. Woundtech takes this incident and security of personal information in its care very seriously. Upon learning of this incident, Woundtech moved quickly to investigate and respond to the incident. As part of its ongoing commitment to the security of information, Woundtech is reviewing and enhancing its existing policies and procedures related to data privacy to reduce the likelihood of a similar future incident. In addition, Woundtech has notified and is cooperating with appropriate law enforcement.

How Will Individuals Know If They Are Affected By This Event? Woundtech is mailing a notice letter to individuals whose information was determined to be in the affected files, for whom a valid mailing address is available. If an individual does not receive a letter but would like to know if they are affected, they may call Woundtech’s dedicated assistance line, detailed below.

Whom Should Individuals Contact For More Information? If individuals have questions or would like additional information, they may call Woundtech’s dedicated assistance line at 833-297-3496, Monday through Friday from 8:00 a.m. to 8:00 p.m. Eastern Time, excluding major U.S. holidays. Please have this letter ready if you call between the hours.

What You Can Do. We encourage individuals to remain vigilant against incidents of identity theft and fraud by reviewing your account statements, explanation of benefits forms, and monitoring your free credit reports for suspicious activity and to detect errors. Under U.S. law individuals are entitled to one free credit report annually from each of the three major credit reporting bureaus. Individuals may also contact the three major credit bureaus directly to request a free copy of their credit report, place a fraud alert, or a security freeze. Contact information for the credit bureaus is below:

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you may need to provide the following information, depending on whether the request is made online, by phone, or by mail:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;

- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

Instances of known or suspected identity theft should also be reported to law enforcement and your state Attorney General. This notice has not been delayed by law enforcement.
