**Notice of Security Incident**

Dear Sample A. Sample,

AOTCO Metal Finishing, LLC (“AOTCO,” “we,” “us,” “our”) recently experienced a data security incident that could affect some of your personal information. AOTCO takes the protection of our employees’ information seriously, and while we have no direct evidence that your information was used by any unauthorized individuals, out of an abundance of caution, we are contacting you directly to let you know what occurred and the resources you can use to monitor your personal information and help protect against identity theft.

**What Happened?**

---

On or about March 27, 2026, AOTCO discovered that a threat actor had potentially accessed and exfiltrated certain files on our network, some of which may have contained personal information. AOTCO promptly engaged a third-party forensics firm to investigate the incident and disabled the network.

**What Information Was Involved?**

---

The personal information impacted by this incident may include Social Security Numbers, drivers’ license numbers, payroll information, 401(k) information, tax forms, health insurance information and information contained in offer letters.

**What We Did**

---

AOTCO notified government authorities of the incident, secured the impacted network and disabled the impacted VPN. AOTCO also forced a password reset for employees and implemented additional cyber awareness trainings and other security measures.

Additionally, while we are not aware of any misuse of your information at this time, as a precaution to help protect your identity, we are offering complimentary access to Experian IdentityWorks<sup>SM</sup> for 24 months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

Please note that Identity Restoration is available to you for 24 months from the date of this letter and does not require any action on your part at this time. The Terms and Conditions for this offer are located at [www.ExperianIDWorks.com/restoration](http://www.ExperianIDWorks.com/restoration).

While identity restoration assistance is immediately available to you, we also encourage you to activate the fraud detection tools available through Experian IdentityWorks as a complimentary 24-month membership. - Ensure that you **enroll by** August 30, 2026 by 11:59 pm UTC (Your code will not work after this date.)

**Free Credit Report.** It is recommended that you remain vigilant by reviewing account statements and monitoring your credit report for unauthorized activity, especially activity that may indicate fraud and identity theft. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting agencies.

**For Massachusetts residents:** You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

**Fraud Alerts.** There are two types of fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for at least one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft and you have the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. You can place a fraud alert on your credit report by contacting any of the three national credit reporting agencies.

**Security Freeze.** You have the ability to place a security freeze, also known as a credit freeze, on your credit report free of charge.

A security freeze is intended to prevent credit, loans and services from being approved in your name without your consent. To place a security freeze on your credit report, you may use an online process, an automated telephone line, or submit a written request to any of the three credit reporting agencies listed above. The following information must be included when requesting a security freeze (note that, if you are requesting a security freeze for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past 5 years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, and display your name, current mailing address, and the date of issue.

**Federal Trade Commission and State Attorneys General Offices.** If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or minimize the risks of identity theft.

**Reporting of Identity Theft and Obtaining a Police Report.**
