Dear Sample A. Sample:

Hy LaBonne & Sons, Inc. (“LaBonne’s Markets”) writes to inform you of a recent event that may involve certain information related to you. Although LaBonne’s Markets presently has no evidence that any such information has been used to commit identity theft or fraud, we are providing information about the event, the steps we have taken in response, and resources available to individuals to help protect information from possible misuse, should you feel it is appropriate to do so.

What Happened? On October 20 of last year, we became aware of suspicious activity affecting certain systems within our computer network. We promptly launched an investigation to confirm the full nature and scope of the activity with the assistance of industry-leading cybersecurity specialists. We also notified federal law enforcement. The investigation determined there was unauthorized access to a subset of our network on October 20, 2025, and that certain files within the network were accessed or downloaded without authorization during that time.

As part of our response efforts, we performed a comprehensive third-party review of the impacted files to determine what information was contained within the files and to whom the information related. Following the third-party review, we undertook a detailed internal review of our records to identify contact information to provide notifications. We recently concluded this review.

What Information Was Involved? The impacted information related to you may include your [Extra1], in addition to your name.

What We Are Doing. LaBonne’s Markets takes this event and the security of information in our care very seriously. Upon learning of this event, we promptly commenced an investigation and took remediation actions. As part of our ongoing commitment to the privacy of information in our care, we are reviewing our policies, procedures, and processes to reduce the likelihood of a similar future event. We also reported the event to appropriate governmental agencies and federal law enforcement.

As an added precaution, we are offering you access to [Extra4] months of credit monitoring and identity theft protection services through Experian at no cost to you. If you wish to activate these services, you may follow the instructions enclosed with this letter. We encourage you to enroll in these services as we are unable to do so on your behalf.

What You Can Do. As a precautionary measure, individuals are encouraged to remain vigilant against incidents of identity theft by reviewing account statements and credit reports for unusual activity and to detect errors. Any suspicious activity should be promptly reported to the appropriate financial institution. Additional information can be found in the *Steps You Can Take to Help Protect Personal Information*.

Enroll in Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for [Extra4] months.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state attorney general. The Federal Trade Commission also encourages those who discover that their information has been misused to file a complaint with them. Consumers have the right to file a police report if they ever experience identity theft or fraud. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state attorney general. This notice has not been delayed by law enforcement.
