

# **EXHIBIT 1**

By providing this notice, CGP&H, LLC (“CGP&H”) does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

### **Nature of the Data Event**

CGP&H became aware of suspicious activity on its computer network. CGP&H promptly launched an investigation with the assistance of third-party specialists into the nature and scope of the incident and took steps to secure its network. Through that investigation, CGP&H determined that an unknown actor gained access to certain parts of its network between June 19, and June 20, 2025, and may have accessed or acquired certain files while on the network. CGP&H then began an in-depth process to identify the information that may have been contained in the impacted files and identify the individuals whose information may have been impacted. CGP&H then reviewed its internal records to identify address information for potentially impacted individuals. This process was completed on May 7, 2026. CGP&H then provided notice to impacted individuals based on this review.

The information that could have been subject to unauthorized access includes name and Social Security number/Individual Taxpayer Identification Number.

### **Notice to Maine Resident**

On or about June 1, 2026, CGP&H began providing written notice of this incident to one (1) Maine resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

### **Other Steps Taken and To Be Taken**

Upon discovering the event, CGP&H moved quickly to investigate and respond to the incident, assess the security of CGP&H systems, and identify potentially affected individuals. Further, CGP&H notified federal law enforcement regarding the event. CGP&H is also working to implement additional safeguards and training to its employees. CGP&H is providing access to credit monitoring services for twelve (12) months, through Cyberscout, a TransUnion company, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, CGP&H is providing impacted individuals with guidance on how to better protect against identity theft and fraud. CGP&H is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

CGP&H is providing written notice of this incident to relevant state regulators, as necessary, and to the three (3) major credit reporting agencies, Equifax, Experian, and TransUnion.

**NOTICE OF SECURITY INCIDENT**

Dear [Redacted]:

CGP&H, LLC (“CGP&H”) writes to notify you of an incident that may affect some of your personal information. Safeguarding information is among CGP&H’s highest priorities, and this letter provides details of the incident, our response to it, and steps you may take to better protect against the possible misuse of your information, should you feel it is appropriate to do so.

**What Happened?** CGP&H became aware of suspicious activity on our computer network. CGP&H promptly launched an investigation with the assistance of third-party specialists into the nature and scope of the incident and took steps to secure our network. Through that investigation, CGP&H determined that an unknown actor gained access to certain parts of our network between June 19, and June 20, 2025 and may have accessed or acquired certain files while on the network. We then began an in-depth process to identify the information that may have been contained in the impacted files and identify the individuals whose information may have been impacted. We then reviewed our internal records to identify address information for potentially impacted individuals. This process was completed on May 7, 2026. We are notifying you because the investigation determined that certain information relating to you was included in the affected files.

**What Information Was Involved?** The information contained in the affected files included your name and the following information: Social Security number/Individual Taxpayer Identification Number, driver's license number/state identification number, other government identification number, and financial account information. CGP&H is not aware of any fraud or identity theft related to this event.

**What We Are Doing.** We take this incident and the security of information in our care seriously. Upon learning of this incident, we immediately secured our environment, investigated to determine the nature and scope of the incident, and notified federal law enforcement. We have also implemented additional technical safeguards to help prevent a similar incident in the future. CGP&H is offering you access to 12 months of complimentary credit monitoring and identity protection services through Cyberscout, a TransUnion company. Details of this offer and instructions on how to enroll in the services may be found in the attached *Steps You Can Take to Help Protect Personal Information*. If you would like to enroll in these services you will need to follow the attached instructions, as we are unable to enroll you automatically.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the

next twelve (12) to twenty-four (24) months. Additional information, including steps to enroll in credit monitoring, may be found in the *Steps You Can Take to Help Protect Personal Information* section below.

## Steps You Can Take To Help Protect Personal Information

### Enroll in Monitoring Services

To enroll in Credit Monitoring services at no charge, please log on to <https://bfs.cyberscout.com/activate> and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED]. In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

### Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
