Dear Sample A. Sample:

Santa Monica Community College District (“SMC”) writes to notify you of a recent event that may affect the privacy of certain information, as described below. This letter includes information about the event, our response, and resources we are making available to you. We take very seriously the responsibility of protecting the privacy of the information in our care, and are committed to taking proactive, corrective action to prevent such incidents from occurring in the future.

What Happened? On May 14, 2026, we identified that employee W-2s were emailed to two former student workers and immediately launched an internal investigation. A thorough investigation determined that the impacted information was subject to unauthorized access from April 13, 2026, to May 21, 2026. We have since confirmed the email has been deleted and have no evidence of misuse of any information by either recipient. On May 25, 2026, we completed our review, which included obtaining up-to-date address information for all impacted individuals in order to provide you with this notification at the earliest possible time.

What Information Was Involved? The types of information that may have been involved include your first and last name in combination with the following information: Social Security number.

What We Are Doing. We have taken steps to address this event, and to prevent such disclosures from happening in the future. In response, we conducted a thorough investigation, reviewed our policies and procedures related to data protection, and implemented additional safeguards. Out of an abundance of caution, we have also arranged for you to enroll, at no cost to you, in credit monitoring and identity protection services for [Extra2].

What You Can Do. We encourage you to enroll in the credit monitoring and identity protection services that we are making available to you at no cost. Instructions about how to enroll in these services and additional resources available to you are included in the enclosed *Steps You Can Take to Protect Your Information*.

We understand you may have questions about this event. You may contact our dedicated call center at 833-918-9466, Monday through Friday from 9 am - 9 pm Eastern Time, excluding major U.S. holidays or write to us at 1900 Pico Blvd, Santa Monica, CA 90405. We recommend that you remain vigilant against incidents of identity theft and fraud by reviewing your credit reports, account statements, and explanation of benefits forms for suspicious activity and to detect errors. If you discover any suspicious or unusual activity on your accounts, please promptly contact your financial institution or company.

We sincerely regret any concern this event may cause you. The privacy and security of information are important to us, and we will continue to take steps to protect information in our care.

STEPS YOU CAN TAKE TO HELP PROTECT YOUR INFORMATION

Activate Credit Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for [Extra2] months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. Monitor Your Accounts

Under U.S. law, you are entitled to one free credit report annually from each of the three major credit reporting bureaus, TransUnion, Experian, and Equifax. To order your free credit report, visit www.annualcreditreport.com or call 1-877-322-8228. Once you receive your credit report, review it for discrepancies and identify any accounts you did not open or inquiries from creditors that you did not authorize. If you have questions or notice incorrect information, contact the credit reporting bureau.

You have the right to place an initial or extended fraud alert on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any of the three credit reporting bureaus listed below.

As an alternative to a fraud alert, you have the right to place a credit freeze on a credit report, which will prohibit a credit bureau from releasing information in the credit report without your express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., III, etc.);
2. Social Security number;
3. Date of birth;
4. Address for the prior two to five years;
5. Proof of current address, such as a current utility or telephone bill;
6. A legible photocopy of a government-issued identification card (e.g., state driver’s license or identification card); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft, if you are a victim of identity theft.
