NOTICE OF [Extra2]

Dear Sample A. Sample:

Precipart Corporation (“Precipart” or “we”) is writing to make you aware of an event involving some of your information. Although we have no indication that identity theft or fraud has occurred as a result of this event, this notice provides information about this event, our response, and resources available to you to help protect your information, should you feel it is appropriate.

What Happened? On or about February 6, 2026, Precipart became aware of suspicious internal system activity and promptly began an investigation into the nature and scope of the issue. The investigation determined that an unknown actor accessed certain Precipart systems between January 28, 2026, and February 4, 2026, and copied certain files from those systems during that period. We conducted a comprehensive review of the potentially affected files to determine what types of information were present and to whom the information relates. You are receiving this letter because we recently completed this review and some of your information was found in the relevant files.

What Information Was Involved? Our review determined that information present in the relevant files included your [Extra1], and name.

What We Are Doing. When we identified this issue, we acted quickly to secure our systems. We also conducted a thorough investigation to determine the full nature and scope of the event. Additionally, we reported the event to federal law enforcement. As part of our ongoing commitment to information security, we continue to evaluate and enhance our existing technical safeguards. As an added precaution, we are offering you access to credit monitoring and identity theft protection services for 24 months at no cost to you, through Experian. We encourage you to enroll in these services as we are unable to do so on your behalf.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and credit reports for suspicious activity and to detect errors. In addition, you can enroll in the free credit monitoring services that we are providing. Please note, you must enroll by December 31, 2026 to take advantage of these services. We also recommend that you review the *Steps You Can Take to Help Protect Your Information* section of this letter to learn helpful tips on steps you can take to protect against possible information misuse, should you feel it is appropriate to do so. In this section, you will also find enrollment instructions for credit monitoring services.

Enroll in Monitoring Services

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for 24 months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
